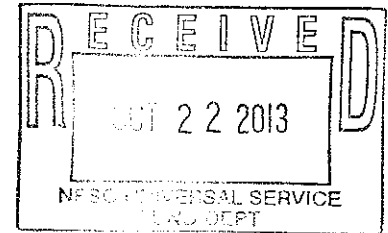

PREFILED TESTIMONY OF SUE VANICEK

2 **Q: Please state your name for the record.**  
3 A: Sue Vanicek, V-A-N-I-C-E-K  
4 **Q: Where are you employed and in what capacity?**  
5 A: I am the Director of the Nebraska Telecommunications  
6 Infrastructure and Public Safety Department of the Nebraska  
7 Public Service Commission which administers the Nebraska  
8 Universal Service Fund. I have been employed by the  
9 Commission as Director since August 14, 2008.  
10 **Q: What Was Your Experience Prior To Your Current Position?**  
11 A: For 14 years I was employed by Lincoln Telephone/Aliant  
12 Communications. I held a variety of positions specializing  
13 in regulatory and legislative analysis and strategic  
14 planning. There I also served as Economic Costs and  
15 Analysis Manager. In that position I was responsible for  
16 managing the development of cost information, both forward-  
17 looking and historical. After leaving Aliant, I was

1 employed as a Senior Consultant at TELEC Consulting  
2 Resources now known as Consortia Consulting.

3 **Q: What Is Your Educational Background?**

4 A: I have Master of Arts degree in Economics and a Bachelor of  
5 Science degree in Business Administration, both from the  
6 University of Nebraska-Lincoln.

7 **Q: What is the purpose of your testimony?**

8 A: To make recommendations and to discuss the Department's  
9 opinion regarding the application of N.E. Colorado  
10 Cellular, Inc., d/b/a Viaero Wireless (Viaero).

11 **Q: Will you please describe the Department's views regarding**  
12 **Viaero's application for NUSF support?**

13 A: Yes. My testimony will generally support the grant of  
14 support to Viaero. The Commission has conditioned the  
15 grant of dedicated wireless fund program support on  
16 compliance with several requirements in prior years. I  
17 will briefly discuss these requirements.

18 **Q: Please describe the conditions the Commission has adopted**  
19 **in order for an applicant to receive Dedicated Wireless**  
20 **Fund Program support.**

21 A: The Commission has adopted five conditions for carriers  
22 seeking Dedicated Wireless Fund Program support. First,  
23 the Commission will approve new towers only in high-cost  
24 unserved and underserved areas. Mr. Tyler Frost, the

1 Commission's economist, will present testimony more fully  
2 explaining the staff's methodology for determining towers  
3 which meet these criteria and for ranking the proposed  
4 tower locations in order to receive benefits for the  
5 greatest number of households.

6 Second, the Commission requires a carrier receiving support  
7 to construct the towers in such a way that the towers would  
8 be able to accommodate the collocation of additional  
9 equipment, such as CDMA and GSM, and have space reserved on  
10 those towers for public safety equipment. Third, the  
11 Commission requires a carrier receiving support to enter  
12 into roaming agreements with other carriers where  
13 technically feasible. Fourth, the Commission requires a  
14 carrier receiving support to place equipment on its towers  
15 to ensure that it is Phase II E911 capable in the event  
16 that it is requested to provide Phase II E911 by the  
17 particular PSAP in the area. Finally, the Commission will  
18 require a commitment from dedicated wireless fund program  
19 recipients which provide mobile broadband service in  
20 Nebraska to submit broadband availability data to the  
21 Commission and its vendors for the duration of the State  
22 Broadband Data and Development (SBDD) program so that this  
23 broadband coverage area can be depicted on the Commission's  
24 state broadband data inventory map and on the National

1 Telecommunications and Information Administration's  
2 (NTIA's) national broadband map. This requirement applies  
3 to all towers a carrier operates which provide broadband  
4 service, not only the towers for which a carrier may  
5 receive dedicated wireless fund program support. The data  
6 should be updated on the schedule for updating data under  
7 the SBDD program, which calls for semiannual updates.

8 **Q: Does this conclude your testimony?**

9 **A: Yes it does.**
