Enclosed herein are an original and one (1) copy of 34th Revised Sheet No. 7.1 of NorthWestern's Gas Tariff.

Sheet No. 7.1 reflects changes in the costs of purchased gas to be effective November 2, 2018. The effect of Sheet No 7.1 for a typical space heating customer using 150 therms per month would be a decrease in the cost from \$95.63 to \$94.93.
