This application form is to be completed by any motor carrier authorized by the Nebraska Public Service Commission to provide transportation services to passengers and their baggage as either a certificated common carrier or permitted contract carrier. This application must be approved by the Commission prior to using these rates.

- 1. If you hold a permit as a transportation network company, a household goods mover license, or a railroad crew transport license, do not complete this form. Please contact the Transportation Department regarding the process to inform the Commission of your rates and charges.
- 2. This application must be submitted to the Commission with the required supporting information. The application may be downloaded from the Commission website: https://psc.nebraska.gov, or contact the Commission to request an application. All applicable blanks MUST be completed for an application to be processed.
- 3. The application must be completed by a person authorized to complete such forms on behalf of the company.
- 4. Clearly indicate the rates and charges proposed to be used. Indicate whether a rate or charge is new or a change to an existing rate and provide the previously approved rate along with the change. Clearly state the basis for the rate or charge and provide any supporting documentation that will justify the need for the rate or charge. Failure to include the basis for the rate or charge and failure to provide existing rates may result in delay in processing.
- 5. Indicate whether emergency action is requested. If so, please provide justification for the emergency request. Applications in which no emergency action is requested are subject to a thirty (30) day publication period before rates are presented to the Commission for approval. Applications are not published until a completed application is received. All rate applications, regardless of if a protest is received, are subject to a possible hearing if necessary.
- A non-refundable application fee of \$100.00 is required with the application.
 Fees are payable online at https://psc.nebraska.gov, by check/money order by mail, or by cash/check/money order in person at the Commission. DO NOT SEND CASH IN THE MAIL.
