# GIS Working Group

- The PSC has PSAP boundary work in progress.
  - 32% of PSAPs have confirmed boundaries
- GIS Cooperative Agreement
  - Model for county to county GIS boundary communication
  - Provides summary of roles and responsibilities between PSAPs
    - Coordination of data
    - Communication if there are boundary changes
  - Suggests annual review between neighboring PSAPs

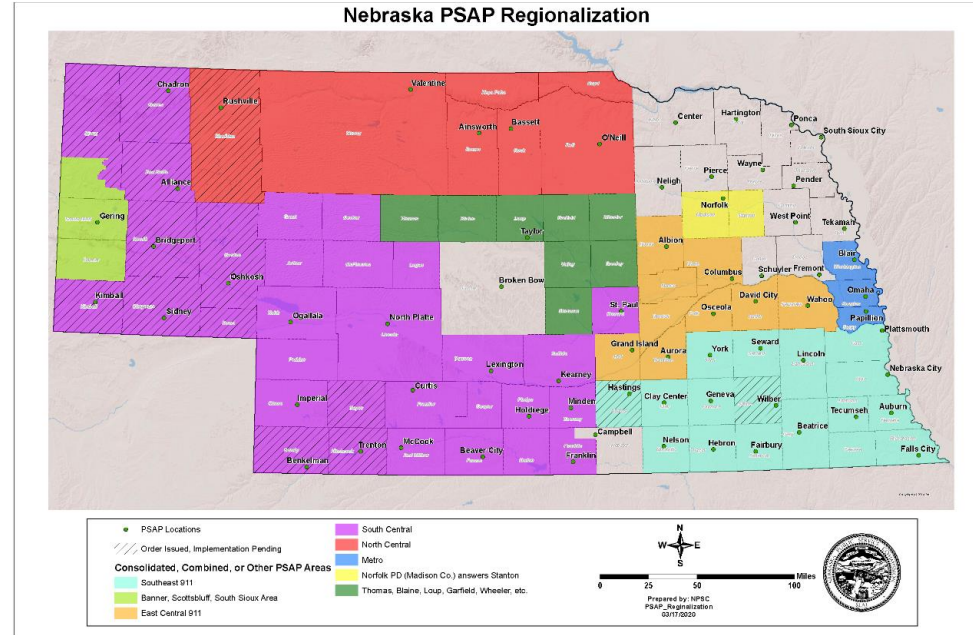


Diagram current as of March 2020
