AFTER DUE INVESTIGATION, it is hereby certified that the above-named carrier has complied with all applicable provisions of Neb. Rev. Stat., Sections 75-301 to 75-322.04, (Reissue 2017), and the requirements, rules and regulations prescribed thereunder and, therefore, is entitled to receive authority from the Nebraska Public Service Commission to engage in transportation in Nebraska intrastate commerce as a motor carrier.

IT IS CERTIFIED, that pursuant to the Commission's Order, the said carrier be, and it is hereby, issued this Certificate of Public Convenience and Necessity as evidence of the authority of the holder to engage in transportation in Nebraska intrastate commerce as a common carrier by motor vehicle; subject, however, to such terms, conditions and limitations as are now, or may hereafter be, attached to the exercise of the privileges granted to the said carrier.

AND IT IS FURTHER CERTIFIED, that the transportation service to be performed by the said carrier in Nebraska intrastate commerce shall be as specified below:

- (A) Passengers and their baggage by vans between points in Dundy, Hitchcock, Red Willow Chase, Hayes, Frontier, Perkins, Lincoln, Dawson, Keith, Deuel, Garden, Morrill, and Cheyenne counties over irregular routes. RESTRICTION: Transportation of railroad train crews and their baggage is not authorized. (B) Passengers and their baggage by vans between points in Furnas, Gosper, Harlan, Phelps, Buffalo, Kearney, Adams, Hall, Hamilton, York, Seward, Cass, Sarpy, Douglas, Lancaster, Hooker, McPherson, Thomas, and Logan counties over irregular routes. RESTRICTIONS: (1) Transportation of railroad train crews and their baggage is not authorized; and, (2) Point-to-point service within the City of Lincoln is not authorized, except for transportation of friends or relatives of passengers already aboard which have originated or will terminate in communities outside of Lincoln, the Lincoln Municipal Airport to medical facilities, the University of Nebraska, the Amtrak Station and/or the Cornhusker Hotel.

RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. Point-to-point service within the City of Lincoln is not authorized, except for transportation of friends or relatives of passengers already aboard which have originated or will terminate in communities out of Lincoln from the Lincoln Municipal Airport to medical facilities, the University of Nebraska, the Amtrak Station, and/or the Cornhusker Hotel. The transportation of clients of Nebraska Department of Health and Human Services, such as, but not limited, Access to Care (AMR) and/or person in the custody of the Nebraska Department of Corrections, in capacity of such clients and/or persons in custody is not authorized in Butler, Colfax, Madison, Merrick, Platte, Polk, Saunders, and Stanton counties. Current certificate Parts (A), (B) and Supplement 1 is to be revoked upon granting of Supplement 2. HHS Designation: Yes.
